I HEREBY AGREE UNDER PENALTIES OF PERJURY that by signing this registration form that I will abide by all rules and regulations as set forth by Fulton and Brewerton Speedways including, but not limited to, the following:

- 1) I agree to abide by all car specifications and safety rules;
- 2) I agree and understand that by submitting my race car for various technical and safety inspections, I certify that the race car meets all rules and regulations for participation at Fulton and/or Brewerton Speedway, and I understand that the burden of proof will rest upon me to show that I am in compliance with all Fulton and Brewerton Speedway rules and regulations, and I understand that any violation of such rules and regulations may result in confiscation of illegal parts, fines, suspension, and/or loss of points;
- 3) I agree that all decisions of race officials, or track officials, regarding the interpretation and application of the Fulton and/or Brewerton rules, regulations and the scoring of positions (race day decisions), shall be non-litigable.
