I HEREBY CERTIFY UNDER PENALTIES OF PERJURY, that any license hereunder is granted for the sole purpose of enabling me to participate in a race, or other motorsports-related activity. My presence in, about, or enroute to or out of the Fulton and/or Brewerton Speedway is in furtherance of that Fulton or Brewerton Speedway event. I HEREBY AGREE UNDER PENALTIES OF PERJURY that by signing this registration form that I will abide by all rules and regulations as set forth by Fulton and Brewerton Speedways including, but not limited to, the following:

- 1) I agree to abide by all car specifications and safety rules;
- 2) I agree and understand that by submitting my race car for various technical and safety inspections, I certify that the race car meets all rules and regulations for participation at Fulton and/or Brewerton Speedway, and I understand that the burden of proof will rest upon me to show that I am in compliance with all Fulton and Brewerton Speedway rules and regulations, and I understand that any violation of such rules and regulations may result in confiscation of illegal parts, fines, suspension, and/or loss of points;
- 3) I agree that all decisions of race officials, or track officials, regarding the interpretation and application of the Fulton and/or Brewerton rules, regulations and the scoring of positions (race day decisions), shall be non-litigable.
- 4) I hereby assign to Fulton and Brewerton Speedway and its assigns, the non-exclusive rights to my image and likeness, and the image of my vehicle, whether portrayed in still or action pictures, drawings, or other artistic renderings, relating to or depicting my participation; but only in connection with advertising and promotions relating to the Events;
- 5) I further understand that there is no express or implied warranty of safety resulting from publication or compliance with Fulton and Brewerton Speedway rules, and that they are intended merely as a guide and are minimum requirements for the conduct of the sport and are in no way a guarantee against injury or death to participants, spectators, or others;
- 6) I understand that I am not an agent or employee of Fulton or Brewerton Speedway. Further, I understand that I am solely responsible for compensating my employees, agents or pit crew members. I also assume full responsibility for reporting or filing any reports or tax returns with the appropriate authorities on any and all earnings or funds received as a result of my participation in Fulton and/or Brewerton events, including, but not limited to, Federal Social Security taxes, Federal income taxes, State income taxes, Federal and State withholding taxes, unemployment taxes and workers compensation insurance;

Further, I acknowledge that auto racing and related events are HAZARDOUS activities which carry with them significant risk of personal injury, death, or property damage. I also understand that there are natural, mechanical, and environmental conditions and risks which independently or in combination with the activities may cause property damages or severe or even fatal injuries to me or others. I have made a voluntary choice to participate in the activities. I agree to accept all responsibility for the risks, conditions and hazards which may occur whether or not they are known or contemplated by me. Except as set forth below, I hereby expressly assume any and all of the foregoing risks including the risks of injury, death, or property damage and accept sole responsibility for the safety and medical insurance costs of the participant. I further agree to forever release and hold harmless and indemnify Circle L, LLC; MDL Brewerton, LLC, their subsidiaries, directors, officers, agents, employees, officials, assigns, and participants thereon, for all accidents, losses, injuries (including, but not limited to death), or other casualty arising out of my participation in, about, or enroute to and out of the premises.
