This permit allows the Owner/Driver to operate the vehicle in the Fulton Speedway pit area only. Owner/Driver must follow the rules of the facility as set forth below. Owner/Driver agrees to hold harmless the facility owners, lessors and all other parties involved with operation and production of this event. By operating this vehicle during the event, the Owner/Driver agrees they are liable for any damages or injuries to themselves, others and any properties. The Owner/Driver agrees to the following rules:

- 1. Hereby understand racetrack insurance may not cover accidents or claims involving vehicle.
- 2. Hereby agrees that this registration can be revoked at any time for cause as determined by Fulton Speedway Officials.
- 3. Hereby agrees that licensed motorized vehicles will be used for racing related activities only.
- 4. Hereby agrees that licensed motorized vehicles may not be used in the parking lot or the grandstand area at any time.
- 5. Hereby agrees that licensed motorized vehicles may only be brought into the pits on a race car hauler. No separate vehicle will be permitted.
- 6. Hereby understands licensed motorized vehicles are not allowed on the racing surface at any time. The only exception being those used for pushing sprint cars. When pushing a sprint car, operator must wear a suitable helmet.
- 7. Hereby agrees that no one under 16 years of age will operate the motorized vehicle.
- 8. Hereby agrees that only riders that have a seat will be permitted to ride the motorized vehicle.
- 9. Hereby agrees that only one motorized vehicle is allowed per registered car.
- 10. Hereby states that they are familiar with, and will abide by, all motorized vehicle permit rules and regulations.
- 11. Hereby agrees that motorized vehicle is insured.
