Fulton Speedway Camping Lot Schedule, Policies and Procedures

September 27–October 2

Schedule (v8/8/23)

Wed., 9/27	11am	Camping Lot Opens for Outlaw 200 Weekend Lot remains open 24 hours per day until the event concludes Permit required - \$100 (includes two passes to the Thursday 9/28 event) Permit available at camping center upon arrival
Mon., 10/2	12pm	Camping area closed

Procedures and Regulations

1. Camping is available on a first come-first served basis beginning Wednesday, September 27 at 11am. If the camping lot reaches capacity, the adjacent Virgilio's Event Center becomes a secondary camping lot.
2. All campers should enter the grounds using the north spectator entrance upon arrival and check in at the camping center.
3. All campers must be registered using the form attached. Campers are encouraged to complete registration form ahead and present to the camping center upon arrival.
4. After successful registration, our camping attendants will take you to the next available camping spot.
5. There are no reserved spots, however, our camping attendants will attempt to put you in the space of your choice.
6. The lot is dry camping only with no electric, sewer or water hookups available.
7. Please maintain at least 10' between campers including your awnings.
8. Campfires are permitted but please keep them contained to a 30" maximum fire ring.
9. Absolutely no discharging on speedway property. Violators will be expelled.
10. Please clean up your camping area and dispose of your trash in the dumpster provided in parking lot.

11. Move-out is Monday by 12pm.
12. 2am is quiet time each night.
13. Motorized recreational vehicles (i.e Mini-bikes/Golf Carts/ATV's) are strictly prohibited.
14. Potable water is available at the camping center.
15. Portable toilets and hand wash stations are conveniently placed around the camping area for your use.
16. The Speedway goes to great lengths with state and local agencies to maintain the proper permitting to allow overnight stays. Please respect the property and the policies established.

Notice to campers parked in the Virgilio Event Center Lot:

We are granted the use of this lot courtesy of the owner, who has been very supportive of our events and Outlaw Weekend. However, please help us maintain that good relationship so we may continue to use the property in the future.

2. Fires must be contained in a fire ring
3. Under no circumstances may you go into the main event area and pavilion.
